## 作業簡介

如果您申報有應退稅款，可利用本人、配偶、申報受扶養親屬在郵局之存簿儲金、劃撥儲金或金融機構的新臺幣存款帳戶辦理直接撥付手續。

只要在申報書上「利用存款帳戶退稅欄」將存款人姓名、存款人統一證（編）號、金融機構總分行名稱（郵局局名、局號）帳號等填寫清楚，本局即直接將應退稅款轉帳撥入您指定的存款帳戶，免去您往返銀行領取退稅款的麻煩，既方便又安全，請多加利用。



## Outline

Tax refunds are available through taxpayer, spouse or dependent's bank account. (Post Office's Savings and Giro Account)

As long as you put down the depositor's name, his/her ID No., name of the bank (Post Office), Bank No. (Office Code), and account number accurately on your return, we will transfer the money directly into your assigned account, which is much easier and safer than consuming your time with cashing the checks. Don't forget to take this advantage to obtain your refunds.



## 申請要件

- 有效新臺幣存款帳戶
- 本人、配偶、申報受扶養親屬之帳戶
- 帳戶以統一證號或國民身分證統一編號開戶
- 限申報97年綜合所得稅案件

## Application Requirements

- Existing NT-dollar bank (Post Office) account.
- Any account belongs to taxpayer, spouse or dependant in the same tax return.
- Account opened with an ARC ID or an ROC ID number.
- Only for 2008 individual income tax cases.
